

About eTLipse

eTLipse Computação, Engenharia e Responsabilidade Social Ltda. is a company located in Brazil, specialized in instruction, consulting and services of software development for the Architecture, Engineering and Construction Industry.

About our software

TL Elements - Automation Suite for Autodesk® Revit® is an add-in application provided by paid and annual subscription that enhances the experience of Autodesk® Revit® users by offering a set of automation tools for elements filtering, rooms/building finishing, frame insertion, solids operations, parts handling and express Architecture modelling.

About your personal data and information

In order to use TL Elements, you must have an account at the Amazon® Cognito® service, which will take the user's personal data according to its own privacy policy and to ensure the safe functioning of the authentication/authorization feature that is used by TL Elements.

This third-party authentication/authorization feature provides us the following user personal information:

- Username, name and e-mail;
- Device Identification, to prevent multiple usage in a single account;
- Dates of subscription, last access and expiration of license;
- Statuses of trial and subscription periods.

In order to purchase a Full or Business license to TL Elements, you must have an account at the PayPal® payment service, which will take the payer's personal data according to its own privacy policy as well to ensure the safe identification of licenses subscriptions that is necessary to the authorization system in TL Elements.

This third-party payment feature provides us the following personal information from the payer/subscriber:

- Username, name, address and e-mail;
- Identification of plan/subscription purchased and the benefited user;
- Date and time of subscriptions, updates, cancelations and suspensions;
- Value and currency of the purchase.

Once you have acquired a subscription of TL Elements, by installing and running our software you **are only** asked for authentication data, which is usually an e-mail (or *username*) and a password registered at the Amazon® Cognito® service. No other personal information or payment data is required.

This information is useful not only for authentication/authorization purposes but also for providing support and address requests from users.

Apart from our website (where the user can manage credentials and make payments) and the authentication/authorization process, the code of our software is entirely **focused** on User Interface mechanics and *Revit*® modelling transactions and processes.

Aside from our website (where the user can manage credentials and make payments) and the authentication/authorization service, our software **does not** transfer any kind of data collection log files, such as cookies and other similar tools from your computer.

Our software **does** include external links to our institutional web page, which presents support and instructional material, as well as offers of other products and services by the company.

The TL Elements installer file can be also obtained by the *Autodesk*® *App Store*. In this case, the only personal information we can access is provided by the *Autodesk*® *App Store* once the user has downloaded the installer file of our product, being this personal information the following: *nationality, language, name, operating system, company name, e-mail, date, time and quantity of downloads*, when provided by the user.

About the usage of your personal information

Aside from the *Autodesk*® *App Store*'s, the *Amazon*® *Cognito*® service's and the *PayPal*® service's own privacy policy and our support and authentication/authorization mechanics, the usage of the aforementioned personal data is limited to *eTLipse*'s research, storage and private communication with the users (software updates, new tools and services offered and announced by e-mail). No sharing or public usage is done with the user information provided by the aforementioned third-party features and services.

About your rights

You, as a user, are completely entitled to demand the retrieval, updating, transfer, consulting, rectification and/or deletion of any of your personal data stored in any of our databases, being aware that this information is essential for the proper functioning of our tools and services.
